Multiple benefit payments

You may receive a benefit payment up to 100% of the Critical Illness benefit amount for each different diagnosis, up to the total maximum benefit. (A definition of "different diagnosis" is provided in the certificate of coverage).

Total maximum benefit: The Schedule of Benefits is organized into modules. The total maximum benefit amount is 3 times the Critical Illness benefit amount for each module. Once the total maximum benefit for a module has been paid, no further benefits are payable from the same module.

What else is included?

Wellness Benefit

Complete an eligible health screening test, and we'll send you a benefit payment to use however you'd like.

- Employees receive an annual benefit payment of \$100.
- Spouses receive an annual benefit payment of \$100.
- Children receive 50% of your benefit amount per child, with an annual maximum of \$200 for all children.
- **Consecutive Wellness Benefit:** Receive a one-time increase to your Wellness Benefit coverage amount by completing health screening tests two calendar years in a row.
